

Point to Point Handlers Permit - Application Enquiries 045 445617

Enclosed are details and an application form for a Point to Point Handlers Permit.

This form should be completed in full, signed by the Handler and returned to the Offices of the IHRB, The Curragh, Co. Kildare, R56 Y668.

An emailed copy of the completed and signed renewal application form will be accepted providing that the image is of **high quality and clearly legible**. Free scanning applications are available on android and apple devices. You can email the signed renewal application form to pointtopoint@ihrb.ie

Android Device

- Open Google Drive App
- Tap the large +(Plus) button in the bottom right corner, tap scan
- Point the camera at the document, it will capture the photo automatically when the blue guidelines outline the page. To scan an additional page tap the +(Plus) button in the bottom right corner
- Tap Next to save the document to Google Drive
- Open the scanned document in Google Drive and select Send a Copy to share the document by email

Iphone Device

- Open Preview App
- Tap Scan Documents
- Point the camera at the document, it will capture the photo automatically when the blue guidelines outline the page. To scan an additional point the camera at the document, it will capture the photo automatically
- Tap the Tick button in top right corner to save the document
- Tap  in bottom right corner of the document to share the document by email

Please note - For your application to be processed you must send a certificate of your Public and Employers Liability Insurance (with your completed Handlers Permit application) which must contain:

- Name and Address of the Policy holder, plus yard address if different to home/postal address
- In the business section of the policy, it must state for the 'Training of Racehorses'
- Commencement & expiry dates
- The Irish Horse Racing Regulatory Board must be named as a 'Notice Party'
- If the Insurance policy is due to expire during the term of your Point to Point Handlers Permit, a new policy must be submitted prior to the expiry date
- If you are the current holder of a license to train and have submitted up to date details of your Public and Employers Liability Insurance to the IHRB, you do not have to resubmit a certificate of your insurance with your completed application form

A valid Equine Premises Number for the premises at which horses under your care and control are located must be supplied. You must also include a **copy of the certificate** of confirmation from the Department of Agriculture, Food and The Marine of your Equine Premises Number when returning your completed application form.

- If you are the current holder of a licence to train and have previously submitted a copy of this certificate to the IHRB, you are not required to resubmit a copy of this certificate.
- Point to Point Handlers with an address in Northern Ireland are exempt from this requirement.

The INHSC Directors strongly recommend that all Point to Point Handlers have access to a Microchip Reader in order to confirm the identity of all horses in their care.

It will be necessary for you to open a Handlers Horse Racing Ireland (HRI) account (if you do not already have one) before your Point to Point Handlers application form is lodged at the Offices of the IHRB. All registration charges in relation to Point to Points, including Handlers Permits and the registration of Hunters Certificates will be debited from your Handlers HRI account. Please contact any member of the client accounts team in HRI on 045-455444 should you have any queries in this regard. Once opened, you must ensure that there are always sufficient funds in your HRI account to cover the cost of any charges as otherwise your Handlers Permit and/or Hunters Certificates will not be registered. Any payments received to the IHRB, in any format, cannot be processed and will be returned, this will result in a delay in the registration of your Point to Point Handlers Permit and/or Hunters Certificates.

Please note the following fees for the 2026/27 season:

- Point to Point Handlers Permit registration fee - **€65**
- Hunters Certificate registration fee - **€100** (inclusive of €35 – temporary insurance levy)

Once you receive an official confirmation letter from the IHRB to acknowledge your registration as a Point to Point Handler, you will receive detailed guidance regarding the Weatherbys ePassport Vaccination App. You must then download the Weatherbys ePassport Vaccination App to your mobile device and complete your registration, as all Equine flu vaccinations in relation to horses for which you are intending to register a Hunters Certificate, must be uploaded to the Weatherbys ePassport Vaccination App in advance of lodging Hunters Certificates. If you have previously registered for the Weatherbys ePassport Vaccination App you do not need to re-register.

It will be **mandatory** for all Handlers to supply an email address on the attached form, please ensure the email address provided is current and monitored regularly, as this will be the **primary method of contact**.

The IHRB Data Protection Privacy Notice can be viewed at www.ihrb.ie you should read this policy in advance of completing the attached Point to Point Handlers Permit application form. If you wish to have your details published by the organisations noted, you must give your consent to do so by ticking the box in the relevant Consent Form section.

Please allow up to seven working days for the attached application form to be processed from the time it is received at the Offices of the IHRB.
