

#### Point to Point Multiple Owner Application - Enquiries 045 445617

Enclosed are details and an application form for a Point to Point Multiple Owner.

A Multiple Owner is a group of 2 or more people that own a horse(s). 2 - 4 people registered in a multiple ownership are known as a Partnership. 5 or more people registered in a multiple ownership are known as a Syndicate. All Partnerships and Syndicates must have a Primary Owner that will be the contact person for all correspondence by the IHRB. The Primary Owner must complete their details on page 1, the names of all additional Owners must be listed on page 2 and each Owner must sign in the space provided opposite their name.

All sections of the enclosed application form must be completed in full. Where possible can you please include more than one Primary Owner Forename as each Multiple Ownership is unique and cannot be duplicated.

The Ownership Name to Appear on the Official Racecard is the collective ownership name to be published on the racecard at Point to Point meetings. This name will be followed with the word Partnership (2 - 4 Owners) or Syndicate (5 or more Owners)

A guide to racings colours and all design types is included and will help you in determining the racing colours you provide on the application form.

Once completed in full, the application form should be signed by the Primary Owner and returned to:

An emailed copy of the application form will be accepted providing that the image is of **high quality and shows two full document pages**. You can email the application form to huntercerts@ihrb.ie

There is no fee to be recorded as a Point to Point Multiple Owner.

Please allow up to seven working days to be recorded as a Point to Point Multiple Owner from when the application form is received at the Offices of the IHRB.

Upon being recorded as a Point to Point Multiple Owner, the Primary Owner will receive a confirmation letter by post with details of the unique Point to Point reference number which will be required when registering a Hunters Certificate in the Multiple Ownership name.


